

SKILLCHECK, INC.
SOFTWARE AND MATERIALS LICENSE AGREEMENT

IMPORTANT: BEFORE OPENING OR UTILIZING THE ENCLOSED PRODUCT, CAREFULLY READ THIS LICENSE AGREEMENT.

This document is an agreement ("Agreement") between you, the end user ("You"), and SkillCheck, I that sets forth your rights and obligations with respect to the enclosed software ("Software"), materials, and documentation. BY UTILIZING THE ENCLOSED PRODUCTS, YOU ARE AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT, WHICH INCLUDES THE LICENSE, LIMITATION OF WARRANTY, AND DISCLAIMER OF LIABILITY. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, RETURN THE UNOPENED PRODUCT TO SKILLCHECK OR THE DISTRIBUTOR, IF ANY, WITHIN TEN (10) DAYS FOLLOWING YOUR DATE OF RECEIPT FOR A FULL REFUND.

SkillCheck will grant You a non-transferable, nonexclusive license to use the enclosed machine-readable form of the Software, materials, and documentation (collectively, the "Licensed Materials") as set forth in this Agreement if You agree to the following terms and conditions:

1. **TERM.** This Agreement is effective from the date on which You open the package containing the Licensed Materials, unless you return the Licensed Materials for a refund as set forth above. You may terminate this Agreement at any time by destroying the Licensed Materials, together with all copies, modifications, and portions of the Licensed Materials, in any form, merged into other products or software. This Agreement and your license to use the Licensed Materials will also terminate if You fail to comply with any term or condition herein, as set forth in more detail in Section 7.

2. GRANT OF SOFTWARE LICENSE

(a) The license granted to You by SkillCheck when You open this sealed package authorizes You to use, for internal purposes only, the Software, as indicated in Your purchase order, either (a) on a single computer (or a replacement therefor) by a single user at any given time, or (b) on a network or other multi-user system (including Internet and Intranet deployment solutions), provided that the number of concurrent users shall not exceed the maximum permitted number of concurrent users set forth in Your purchase order. You are also authorized to use the other Licensed Materials in conjunction with Your authorized use of the Software.

(b) The license granted to You by SkillCheck allows you to use the product within your organization for the purposes of testing individuals. Use of the product in order to provide testing services (including fee-based testing services) for parties outside of your organizations is strictly prohibited unless such permission is specifically granted by SkillCheck in a separate licensing agreement.

3. RESTRICTION AGAINST COPYING OR MODIFYING LICENSED MATERIALS.

(a) You may not use, modify, copy, or otherwise reproduce the Licensed Materials, in whole or in part, except as expressly permitted in this Agreement. In no event does the limited copying or reproduction permitted under this Agreement include the right to decompile, disassemble, electronically transfer, or reverse engineer the Software, or to translate the Software into another computer language.

(b) You may make one copy of the Software for backup/archival purposes. You may not copy or otherwise reproduce any other Licensed Materials. All of Your rights to use the Licensed Materials are expressly stated herein and are subject to the further restrictions set forth below; there are no implied rights, and SkillCheck reserves all rights not expressly granted to You.

(c) You must include any copyright, trademark, or other proprietary notice set forth on the label of the media embodying the Software on any copy of the Software in any form, in whole or in part, or on any modification of the Software, or any other work containing the Software or any part thereof.

4. TITLE AND PROPRIETARY RIGHTS.

(a) The Licensed Materials are copyrighted works and are the sole and exclusive property of SkillCheck or its suppliers. This Agreement conveys a limited right to use the Licensed Materials and shall not be construed to convey title to the Licensed Materials to You. You shall not sell, lease, transfer, sublicense, dispose of, or otherwise make available the Licensed Materials, or any portion thereof, to any other party.

(b) You further acknowledge that in the event of a breach of this Agreement, SkillCheck shall suffer severe and irreparable damages for which monetary compensation alone will be inadequate. You, therefore, agree that in the event of a breach of this Agreement, SkillCheck shall be entitled to monetary damages and its attorneys' reasonable fees and costs in enforcing this Agreement, as well as injunctive relief to restrain such breach, in addition to any other remedies available to SkillCheck at law, in equity, or otherwise.

5. PROTECTION AND SECURITY. You agree not to deliver or otherwise make available the Licensed Materials or any part thereof, including without limitation the object or source code (if provided) of the Software, to any party other than SkillCheck or its employees, except for purposes specifically related to Your use of the Software as expressly permitted in this Agreement, without the prior written consent of SkillCheck. You agree to use your best efforts and take all reasonable steps to safeguard the Licensed Materials to ensure that no unauthorized personnel shall have access thereto and that no unauthorized copy, publication, disclosure, or distribution, in whole or in part, in any form shall be made, and You agree to notify SkillCheck of any unauthorized use thereof. You acknowledge that the Licensed Materials contain valuable confidential information and trade secrets, and that unauthorized use, copying, or disclosure thereof would be harmful to SkillCheck and/or its suppliers.

6. MAINTENANCE AND UPDATES. Updates and certain maintenance and support services, if any, shall be provided to You pursuant to the terms of a separate Support and Maintenance Agreement, if SkillCheck and You enter into such an agreement. Except as specifically set forth in such agreement, SkillCheck shall not be under any obligation to provide software updates, modifications, enhancements, or software maintenance and support services to You.

7. DEFAULT AND TERMINATION.

(a) In the event that You fail to keep, observe, or perform any obligation under this Agreement, including a failure to pay any sums when due, SkillCheck may, in addition to any other remedies it may have at law, in equity, or otherwise, terminate this Agreement and Your license to use the Licensed Materials.

(b) Immediately after termination of this Agreement or if You have for any reason discontinued use of the Licensed Materials, You shall destroy the original and any copies of the Licensed Materials, together with all copies, modifications, and portions of the Licensed Materials, in any form, merged into other products or software.

(c) Sections 4, 5, 7, 8, 9, 10, 11, and 12 shall survive termination of this Agreement for any reason.

8. EXPORT RESTRICTIONS. You agree and certify that neither the Licensed Materials, nor any other technical data, nor the direct product thereof, will be exported or re-exported outside the jurisdiction in which You received them, except as permitted by the laws and regulations of the United States and the laws and regulations of the jurisdiction in which You received the Licensed Materials.

9. FEDERAL ACQUISITION. This provision applies to all acquisitions of the Licensed Materials by or for the federal government. By accepting delivery of the Licensed Materials, the government hereby agrees that the Licensed Materials qualify as "commercial" computer software within the meaning of FAR Part 12.212 (October 1995), DFARS Part 227.7202-1 and 227.7202-3 (June 1995), and DFARS 252.227-7014(a) (June 1995). The terms and conditions of this Agreement shall pertain to the government's use and disclosure of the Licensed Materials, and shall supersede any conflicting contractual terms or conditions. If the license fails to meet the government's minimum needs or is inconsistent in any respect with federal procurement law, the government agrees to return the Licensed Materials, unused, to SkillCheck. 10. LIMITED WARRANTY AND LIMITATION OF LIABILITY.

(a) The only warranty SkillCheck makes to You in connection with this license of the Licensed Materials is that if the media on which the Software is recorded is defective (as determined in good faith by SkillCheck), it will be replaced

without charge if the Software and proof of payment of the license fee are returned to SkillCheck or the distributor from whom it was obtained within ninety (90) days of the date of payment of the license fee.

(b) NEITHER SKILLCHECK NOR ITS AFFILIATES MAKES ANY OTHER WARRANTY OR REPRESENTATION, EXPRESS OR IMPLIED, WITH RESPECT TO THE LICENSED MATERIALS, WHICH ARE LICENSED "AS IS". THE LIMITED WARRANTY AND REMEDY PROVIDED ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, AND ANY WARRANTIES ARISING BY STATUTE OR OTHERWISE IN LAW OR FROM COURSE OF DEALING, COURSE OF PERFORMANCE, OR USE OF TRADE, WHICH ARE HEREBY EXPRESSLY DISCLAIMED, AND ANY STATEMENTS OR REPRESENTATIONS MADE BY ANY OTHER PERSON OR FIRM ARE VOID. IF THE EXCLUSION OF ANY IMPLIED WARRANTY IS NOT PERMITTED BY LAW, THE DURATION OF SUCH IMPLIED WARRANTY IS LIMITED TO THE DURATION OF THE LIMITED WARRANTY SET FORTH ABOVE. YOU ASSUME ALL RISK AS TO THE QUALITY, FUNCTION, AND PERFORMANCE OF THE LICENSED MATERIALS.

(c) Some states do not allow limitations on how long an implied warranty lasts and some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation and exclusion may not apply to You. This limited warranty gives You specific legal rights, and You may also have other rights which vary from state to state.

11. DISCLAIMER AND LIMITATION OF LIABILITY.

(a) YOUR SOLE REMEDY AND SKILLCHECK'S SOLE OBLIGATION WITH RESPECT TO ANY CLAIMS, WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE OR PRODUCT LIABILITY), OR OTHERWISE, ARISING OUT OF OR RELATED TO THIS AGREEMENT SHALL BE GOVERNED BY THIS AGREEMENT, AND IN ALL CASES SUCH REMEDY SHALL BE LIMITED TO MONEY DAMAGES NOT EXCEEDING THE LICENSE FEE YOU PAID FOR THE LICENSED MATERIALS

(b) IN NO EVENT SHALL SKILLCHECK (OR ITS SHAREHOLDERS, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, OR ANY OTHER PARTY WHO HAS BEEN INVOLVED IN THE CREATION, PRODUCTION, OR DELIVERY OF THE LICENSED MATERIALS) BE LIABLE TO ANY PARTY FOR ANY SPECIAL, INDIRECT, RELIANCE, INCIDENTAL, EXEMPLARY, COVER, FORESEEABLE, OR CONSEQUENTIAL DAMAGES, INCLUDING LOSS OF DATA, PROFITS, AND GOODWILL, OR FOR INABILITY TO USE THE LICENSED MATERIALS, EVEN IF SKILLCHECK HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

12. GENERAL. This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof, and all prior agreements, representations, statements, and undertakings, oral or written, are hereby expressly superseded and canceled. You shall not assign this Agreement (and any attempt to do so shall be null and void) without the express written consent of SkillCheck. The rights of SkillCheck and Your obligations under this Agreement shall inure to the benefit of SkillCheck's successors and assigns. SkillCheck's waiver of any right shall not constitute a waiver of that or any other right in the future. If any provision of this Agreement is determined to be invalid or unenforceable under any applicable law, it shall be deemed omitted and the remaining provisions shall continue in full force and effect. The rights and obligations of the parties to this Agreement shall be governed and construed in accordance with the laws and in the state and federal courts of the Commonwealth of Massachusetts, without regard to its conflict of law principles. Any action related to this Agreement shall be brought only in the state and federal courts of Massachusetts and both parties waive any objection to the personal jurisdiction of and venue in such courts. The United Nations Convention on Contracts for the International Sale of Goods shall not apply to this Agreement. The official language of this Agreement is English. You hereby acknowledge that, to the extent permitted by law, any other language version of this Agreement is provided to You for convenience only and, accordingly, in the event of any inconsistency or ambiguity between the English and any other language version, the English language version shall prevail.
